## NSWA Supporting University of Alberta's Augustana Indigenous Land-based Learning Program









Earlier this year, Augustana received a Natural Sciences and Engineering Research Council of Canada PromoScience grant to develop a program to engage Indigenous K-12 students in land-based, experiential STEM learning opportunities. The program will run for 3 years and aims to create and deliver hands-on programs and activities about biology, chemistry, math, and astrophysics that center Indigenous ways of knowing and land-based learning approaches. The project will involve collaboration between Indigenous communities, Elders and Knowledge Holders, Indigenous-led partner groups, and other partner groups to support program development and delivery.

NSWA was invited by project lead Glynnis Hood, an environmental science professor at Augustana Campus, to support the first land-based youth camp being run through the program. The camp took place August 15-19th at the University of Alberta Augustana Miquelon Lake Research Station and the Hesje

Observatory. NSWA staff ran a day of hands-on activities relating to watershed health, water chemistry, and the aquatic bugs that live in Miquelon Lake and Grebe Pond. Eleven Indigenous youth participated and conducted basic water quality testing and completed an aquatic bug survey. The youth had a great time examining the aquatic bugs under microscopes back at the station! It is vitally important to create space for Indigenous ways of knowing in STEM and to build opportunities for Indigenous youth to participate fully and authentically in STEM. NSWA is very excited to be involved in this project and is looking forward to supporting future programs and initiatives.

#### WABAMUN WATERSHED MANAGMENT PLAN IMPLEMENTATION





The <u>Wabamun Watershed Management Plan</u> (WMP) was recently set afloat. This plan provides a multi-stakeholder road map for managing watershed health.

During the summer, NSWA's Watershed Planning Coordinator, Kelsie Norton, facilitated and participated in the Wabamun WMP Implementation Steering Committee meeting, that brought together the <u>Wabamun Watershed Management Council</u>, Alberta Environment and Parks, <u>Alberta Lake Management Society</u>, <u>Parkland Counties Sustainability Manager</u>, and a motivated Parkland County Councilor. The committee delved into engaging discussions around implementation strategies to create a pathway that will turn plans into actions. The meeting was followed by a scenic tour around Wabamun Lake, allowing the committee to get up close to tributaries around the lake, the site of the new Parkland County boat launch and even potential restoration sites.

The implementation strategies are mainly focused on water quality, which can be affected by various parameters such as leaking septic systems, invasive species, and high nutrient run-off. These strategies will compliment a 3-year Strategic and Communications Plan that will further advance collaborative watershed management for Wabamun Lake.

#### NOMINATION as a CANADIAN HERITAGE RIVER



The Governments of Canada and Alberta have officially accepted the nomination of the Alberta section of the North Saskatchewan River as a Canadian Heritage River.

The nominated section includes the entire 718 km of the North Saskatchewan River in Alberta from the Banff National Park boundary to the Alberta- Saskatchewan provincial border. The 49 km section of the North Saskatchewan River within Banff National Park was previously designated as a Canadian Heritage River in 1989.

The River can now be considered for full designation under the Heritage Rivers System. Thanks to **Smoky Lake County** for their work on this project involving many partners. Check out the news release.

Alberta Environment has published new notices for the North Saskatchewan River Hazard Study and the St. Albert Flood Hazard Study. The notices provide the public with updates about study progress, and what (if any) revisions we are working on in response to feedback we received from our draft study engagement.
