A collaborative partnership between NSWA and North American Waterfowl Management Plan (NAWMP) to develop the Vermilion Watershed Management Plan was highlighted in the recent NAWMP Annual Report.

The current Alberta NAWMP coordinator, Terra Simieritsch, is quoted in the article as saying, “*The evaluation shows how an alignment of goals among stakeholders and a respectful, forwardthinking, collaborative approach allowed wetlands to be integrated into a watershed planning process in a meaningful way.*”

The NSWA recently received a \$500,000 Canadian Agricultural Partnership Program (CAPP) grant to conduct riparian assessment work for 11 subwatersheds within the North Saskatchewan River and Battle River watersheds. NSWA will be collaborating with the [Battle River Watershed Alliance](#) in sharing the results of the studies with stakeholders, and how to use the information to prioritize protection and restoration projects in both watersheds.

As well, NSWA received a \$130,000 Watershed Resiliency and Restoration Program (WRRP) grant for creating a public web portal to share the results of riparian assessments

completed in the watersheds. This will make information accessible to landowners, planners and the public. A review of municipal policies and bylaws related to riparian area protection and restoration will also be included as part of the scope of the grant.

These grants will enable NSWA to continue the important riparian work that we began in the Modeste, Strawberry and Sturgeon subwatersheds in 2017. These reports are now posted on the NSWA website .

WORLD WATER DAY #YEG




